

## पंचायत के विकास में जेंडर समानता के मुद्दे पर किया गया पंचायत प्रतिनिधियों का उन्मुखीकरण

### नजरिया संवाद पटना-

आज सहयोगी संस्था के द्वारा बिहटा, पटना के पैनाल पंचायत में पंचायत प्रतिनिधियों के लिए एक उन्मुखीकरण कार्यशाला का आयोजन किया गया, यह कार्यक्रम पैनाल पंचायत भवन में संपन्न हुआ। कार्यशाला में पैनाल पंचायत के 16 प्रतिनिधियों के साथ अन्य सामाजिक कार्यकर्ताओं ने प्रतिभागिता की। इनमें 9 महिला प्रतिनिधि भी शामिल हुईं। आज के इस उन्मुखीकरण कार्यक्रम में पंचायत प्रतिनिधियों के साथ पंचायत विकास हेतु योजनाएँ बनाने, योजनाओं में जेंडर समानता स्थापित करने की दिशा में ठोस कदम उठाने एवं समाज में व्याप्त जेंडर भेदभाव एवं हिंसा को समाप्त करने हेतु उनके बहुमुखी भूमिका के बारे में चर्चा की गई। आज के उन्मुखीकरण कार्यशाला में पैनाल पंचायत के उपमुखिया जयशंकर कुमार, सरपंच बबिता देवी के साथ पंचायत समिति सदस्य, पञ्च एवं वार्ड सदस्यों ने प्रतिभागिता की। इस कार्यक्रम में जेंडर समानता स्थापित करने की दिशा में पंचायत प्रतिनिधियों की महत्वपूर्ण भूमिका के साथ पंचायत विकास की योजनाओं में जेंडर समानता बनाने के लिए योजनाओं का कार्यान्वयन करने पर

विस्तारपूर्वक विमर्श किया गया। सहयोगी संस्था की प्रमुख रजनी ने प्रतिभागियों को बताया कि सहयोगी आरम्भ से ही समाज में लैंगिक हिंसा एवं भेदभाव को समाप्त करने के लिए विभिन्न प्रयास करती रही है, सभी हितधारकों के साथ विमर्श स्थापित कर इस दिशा में जागरूकता फैलाती है, अलग-अलग कार्यक्रम, अभियान, रैली, आदि का आयोजन कर समुदाय को इस सामाजिक कुरीति को समाप्त करने हेतु संवेदनशील बनाती है। उन्होंने कहा कि आज का आधुनिक समाज में भी लड़कियों-महिलाओं को घर- बाहर सभी जगह गैर-बराबरी और हिंसा झेलना पड़ता है, कामकाजी महिलाएँ एवं लड़कियाँ तो दोहरी जिम्मेवारी उठाती हैं, उनके स्वास्थ्य, पोषण, शिक्षण, आदी की उपेक्षा की जाती है। कन्या भ्रूण हत्या, बाल विवाह, दहेज प्रथा के विरुद्ध संवैधानिक उपाय किये जाने के बावजूद कुरीतियाँ समाप्त नहीं हुई हैं। ऐसे में पंचायत प्रतिनिधियों एवं विशेषकर महिला प्रतिनिधियों की भूमिका बहुत महत्वपूर्ण हो जाती है। उन्हें अपने क्षेत्र में इसके विरुद्ध समुदाय को जागरूक करना एवं उनकी हरसंभव सहायता करना उनकी जिम्मेवारी है, साथ ही, पंचायत के विकास की योजनाओं में लड़कियों-महिलाओं को बराबरी में लाने के लिए उपाय करने होंगे। स्थानीय सरकार में वे एक चेंज एजेंट की भूमिका निभाएँ, लड़कियों-महिलाओं के स्वास्थ्य, पोषण, शिक्षण, अधिकार को सुनिश्चित करने की दिशा में योजनाएँ बनाएँ एवं उन्हें कार्यान्वित करें। सरपंच बबिता देवी ने कहा कि वास्तव में अभी भी
